Responses from all interested subcontractors and vendors to the Prequalification process will only be accepted utilizing this specific Request for Qualifications (RFQ) form.

It is the responsibility of the subcontractor to verify receipt by Sletten.

Project Description

Sletten Construction of Nevada, Inc. has been awarded a pre-construction contract as the Construction Manager At-Risk (CMAR) for the above reference project. As part of this scope of work we are qualifying subcontractors to bid on the project. The Work of the Project includes new climate controlled offices within the existing WPCF Receiving Area Warehouse, Loading Dock, New CMU Compressor Building to house relocated Digester Gas Compressors, New Instrument Air Dryers, Tool Air Compressors, Mechanical, Electrical, Plumbing Systems, and Underground Utility Relocation and Connections and other improvements.

Final subcontracts will be contingent upon Sletten Construction of Nevada, Inc. presenting an acceptable GMP to the City of Las Vegas and award of the construction phase of the project.
